Safety Messages

To Installers and Operators of Warning Light Equipment

A WARNING

People's lives depend on your proper installation and servicing of Federal Signal products. It is important to read, understand and follow all instructions shipped with the products and the original product. Listed below are some other important safety instructions and precautions you should follow.

- To properly install the lighting and siren systems, you must have a good understanding of automotive systems, along with proficiency in the installation and use of safety warning equipment.
- Do not install equipment or route wiring in the deployment path of an airbag.
- If a vehicle seat is temporarily removed, verify with the vehicle manufacturer if the seat needs to be recalibrated for proper airbag deployment.
- Frequently inspect the light and siren systems to ensure that it is operating properly and that it is securely attached to the vehicle.
- When drilling into a vehicle structure, ensure that both sides of the surface are clear of anything that could be damaged.
- Refer to the instructions packed with related products for additional precautions and information.
- Do not stare directly into the lights at a close range, or permanent damage to your eyesight may occur.
- All effective sirens and horns produce loud sounds (120 dB) that may cause permanent hearing loss. Always minimize your exposure to the sound of the siren and horn and wear hearing protection. Do not sound the siren and horn indoors or in enclosed areas where you and others will be exposed to the sound.
- File these instructions in a safe place and refer to them when maintaining and/or reinstalling the product.

Failure to follow all safety precautions and instructions may result in property damage, serious injury, or death.

Mounting Bracket for ES100C and IMPAXX_®, MicroPulse_® Lights

This publication has instructions for using the Model ESB2-TAH21ND bracket kit to mount the ES100C, or Model ESBL2-TAH21ND bracket kit to mount the ES100C and/or IMPAXX IPX600B, IPX300 or MicroPulse MPS600, MPS600U, MPS1200, MPS1200U, and MPSW9 lights in the grille of the 2021 Tahoe.

NOTE: For electrical installation instructions, refer to the Installation and Maintenance Instructions included with the siren and light head.

Unpacking the Kit

After unpacking the kit, inspect it for damage that may have occurred in transit. If it has been damaged, do not attempt to install or operate it. File a claim immediately with the carrier, stating the extent of damage. Carefully check all envelopes, shipping labels, and tags before removing or destroying them. Ensure that the parts in Table 1 or 2 are included in the package. If you are missing any parts, contact Customer Support at 1-800-264-3578, 7 a.m. to 5 p.m., Monday through Friday (CT).

Installing the Brackets

WARNING

DRILLING PRECAUTION: When drilling holes, check the area you are drilling into to be sure you do not damage vehicle components. All drilled holes should be deburred, and all sharp edges should be smoothed. All wire routings going through drilled holes should be protected by a grommet or convolute/split loom tubing.

IMPORTANT: Plan all cable routing before the installation.



THREAD DAMAGE AND GALLING: To prevent thread damage and galling, use anti-seize lubricant on all stainless steel fasteners

Installing the ESBL2-TAH21ND Bracket

To install the speaker and lights:

- **1.** Remove the vehicle front fascia according to the vehicle manufacturer's instructions.
- 2. Install the speaker bracket to bolts on the vehicle as shown in Figure 1.



- 3. Install the 1/4-inch carriage bolt through the carriage bolt slot on the bracket and through the slot on the vehicle fascia structure. Secure the bolt using the 1/4-inch flat washer and Keps_® nut.




Figure 2 ESBL2-TAH21ND Bracket

- **4.** Install the speakers to the speaker bracket and light head brackets using the 5/16-inch hardware supplied with this kit. The light head brackets should go between the speakers and speaker bracket. See Figure 2.

5. Install the light heads to the speaker brackets using the 6-32 screws and Keps® nuts supplied with this kit.

Installing the Brackets

- **6.** Complete the wiring as indicated by the speaker and light head instruction manuals.
- **7.** Install the front fascia according to the vehicle manufacturer's instructions.
- **8.** Test the lights and speakers for proper operation.

Installing the ESB2-TAH21ND Bracket

To install the speaker and lights:

- **1.** Remove the vehicle front fascia according to the vehicle manufacturer's instructions.
- 2. Install the speaker bracket to bolts on the vehicle as shown in Figure 1 on page 7.
- 3. Install the 1/4-inch carriage bolt through the carriage bolt slot on the bracket and through the slot on the vehicle fascia structure. Secure the bolt using the 1/4-inch flat washer and Keps_® nut.




Figure 3 ESB2-TAH21ND Bracket

- **4.** Install the speakers to the speaker bracket using the hardware supplied with the speaker. See Figure 3

- **5.** Complete the wiring as indicated by the speaker instruction manual.
- **6.** Install the front fascia according to the vehicle manufacturer's instructions.
