# Safety Message to Installers of Warning Light Equipment

### **A** WARNING

People's lives depend on your proper installation and servicing of Federal Signal products. It is important to read and follow all instructions shipped with this product and the original product. In addition, listed below are some other important safety instructions and precautions you should follow:

- To properly install the warning lights, you must have a good understanding of automotive systems, along with proficiency in the installation and use of safety warning equipment.
- Do not install equipment or route wiring in the deployment path of an airbag.
- If a vehicle seat is temporarily removed, verify with the vehicle manufacturer if the seat needs to be recalibrated for proper airbag deployment.
- You should frequently inspect the light system to ensure that it is operating properly and that it is securely attached to the vehicle.
- When drilling into a vehicle structure, be sure that both sides of the surface are clear of anything that could be damaged.
- Refer to the instructions packed with related products for additional precautions and information.
- Do not stare directly into the lights at a close range or permanent damage to your eyesight may occur.
- File these instructions in a safe place and refer to them when maintaining and/or reinstalling the product.

Failure to follow all safety precautions and instructions may result in property damage, serious injury, or death.

#### Introduction

This publication has instructions for using the MPSMW9-DUR15MIR Mounting Kit to mount a MicroPulse® MPSW9 lighthead to the each side mirror of the Dodge® Durango.

**NOTE:** For electrical installation instructions, refer to the Installation and Maintenance Instructions packed with the lighthead.

# **Unpacking the Kit**

After unpacking the kit, inspect it for damage that may have occurred in transit. If it has been damaged, do not attempt to install or operate it. File a claim immediately with the carrier, stating the extent of damage. Carefully check all envelopes, shipping labels, and tags before removing or destroying them. Ensure that the parts in the KIT CONTENTS LIST are included in the package. Disposal of all shipping materials must be carried out in accordance with national and local codes and standards. ### **NOTICE**

DRILLING PRECAUTION: When drilling holes, check the area you are drilling into to be sure you do not damage vehicle components. All drilled holes should be deburred and all sharp edges should be smoothed. All wire routings going through drilled holes should be protected by a grommet or convolute/split loom tubing.

To install the light:

1. Position the bracket as shown and mark mounting holes and a wire access hole.




Figure 1 Mounting bracket position on passenger-side mirror

- 2. Drill three 5/32" (0.156") mounting holes, plus a hole for wire routing.
- **3.** Remove the cover and prepare the wiring.
- 4. Install the bracket to the cover with the two #10 Type B six-lobe screws.
- 5. Reinstall the cover and install the third #10 Type B six-lobe screw into the arm.
- **6.** Install the MPSW9 with the provided 6-32 nuts and screws.
- 7. Repeat the previous steps on the other side of the vehicle.

**8.** Complete the wiring per the instructions supplied with the lighthead.

- **9.** Test the lights for proper operation.
- 10. Reassemble the front of the vehicle according to the manufacturer's service manual.
