Safety Message to Installers of Warning Light Equipment

- If a vehicle seat is temporarily removed, verify with the vehicle manufacturer if the seat needs to be recalibrated for proper airbag deployment.
- Frequently inspect the light system to ensure that it is operating properly and is securely attached to the vehicle.
- When drilling into a vehicle structure, enure that both sides of the surface are clear of anything that could be damaged.
- Refer to the instructions packed with related products for additional precautions and information.
- File these instructions in a safe place and refer to them when maintaining and/or reinstalling the product.
- Do not stare directly into the lights at a close range, or permanent damage to your eyesight may occur.

Failure to follow all safety precautions and instructions may result in property damage, serious injury, or death.

MPSMW9-SHD Mounting Kit

This publication has instructions for using the MPSMW9-SHD Mounting Kit to mount a pair of MicroPulse® MPSW9 light head to the side mirror bracket of the Ford Interceptor Utility.

NOTE: For electrical installation instructions, refer to the installation and maintenance instructions packed with the light head.

Unpacking the Kit

After unpacking the kit, inspect it for damage that may have occurred in transit. If it has been damaged, do not attempt to install or operate it. File a claim immediately with the carrier, stating the extent of damage. Carefully check all envelopes, shipping labels, and tags before removing or destroying them. Ensure that the parts in the Kit Contents List are included in the package. If you are missing any parts, contact Customer Support at 1-800-264-3578, 7 a.m. to 5 p.m., Monday through Friday (CT).

Installing the Brackets


NOTICE

DRILLING PRECAUTIONS: When drilling holes, check the area you are drilling into to be sure you do not damage vehicle components. All drilled holes should be deburred and all sharp edges should be smoothed. All wire routings going through drilled holes should be protected by a grommet or convolute/split loom tubing.


IMPORTANT: Plan all cable routing before the installation.

To mount the shroud bracket:


1. Remove the two #6-32 mounting screws and Keps_® Nuts that are fastened to the MPSW9 light and mounting bracket. See Figure 1.



2. Position the MPSMW9-SHD bracket to the rear of the MPSMW9-FPIU20MIR bracket so that the shroud section of the bracket is closest to the front of the mirror as shown in Figure 2.



- **3.** Use the two #6-32 black oxide mounting screws and the two #6-32 black oxide elastic stop nuts to secure the shroud to the mounting bracket. See Figure 2.
- 4. See Figure 3 for final installation.



5. Repeat steps 1-4 for the other mirror bracket assembly.

6. Test the light for proper operation.
