- Do not stare directly into the lights at a close range or permanent damage to your eyesight may occur.
- File these instructions in a safe place and refer to them when maintaining and/or reinstalling the product.

Introduction

This publication has instructions for using the IPX-GRL8 Grille Mounting Kit to mount the Impaxx 300, 600, Viper EXT, MicroPulse 3 and MicroPulse 6 lightheads in the grille of the Dodge Charger without Rumblers. Use IPX-GRL9 with the RB-CHGR15 Rumbler installation.

Unpacking the Kit

After unpacking the kit, inspect it for damage that may have occurred in transit. If it has been damaged, do not attempt to install or operate it. File a claim immediately with the carrier, stating the extent of damage. Carefully check all envelopes, shipping labels, and tags before removing or destroying them. Ensure that the parts in the KIT CONTENTS LIST are included in the package. Disposal of all shipping materials must be carried out in accordance with national and local codes and standards. Installing the Brackets

A WARNING

IMPORTANT: Plan all cable routing before the installation.


To install the lights begind the grille:

1. Attach the lightheads to the brackets.

IPX600: Use the hardware supplied with the lighthead.

All others: Use the included 6-32 screws and KEPS nuts.

- 2. Disassemble the vehicle per the manufacturer's service manual to access the radiator core support.
- **3.** Connect the lights as described in the instructions provided with the lights.
- **4.** See Figure 1. Secure the brackets to the existing holes in the radiator core support.
- **5.** Reassemble the vehicle.
