

INSTALLATION INSTRUCTIONS FOR #350300-01 Cuda TriOptic™ SUN VISOR

SAFETY MESSAGE TO INSTALLERS

A WARNING

The lives of people depend on your proper installation and servicing of Federal products. It is important to read, understand, and follow all instructions shipped with the products. In addition, listed below are some other important safety instructions and precautions you should follow:

Before Installation

Qualifications

- To properly install this product, you should have a good understanding of automotive electrical procedures and systems, along with the proficiency in the installation and use of safety warning equipment.
- Never attempt to install aftermarket equipment that connects to the vehicle wiring, without reviewing a vehicle wiring diagram - available from the vehicle manufacturer. Insure that your installation will not affect vehicle operation and safety functions or circuits.

During Installation

- DO NOT install equipment or route wiring in the deployment path of an air bag.
- Locate the light control so the VEHICLE and CONTROL can be operated safely under all driving conditions.

After Installation

- Do not attempt to activate or deactivate the light control while driving in a hazardous situation.
- You should frequently inspect the light mounting assembly to ensure that it is operating properly and that it is securely attached to the vehicle.
- This product is used with high intensity LED devices. To prevent permanent eye damage, DO NOT stare into the light beam at close range.
- Test all vehicle functions, including the Cuda TriOptic SignalMasterTM operation, and vehicle safety functions to ensure proper operation. Ensure that the installation has not affected vehicle operation or changed any vehicle safety function or circuit.

- After testing is complete, provide a copy of these instructions to the instructional staff and all operating personnel.
- File these instructions in a safe place and refer to them when maintaining and/or reinstalling the product.

Failure to follow all safety precautions and instructions may result in property damage, serious injury, or death to you or others.

A. GENERAL.

The #350300-01 is a sun visor designed for use in conjunction with the Federal Signal 352022 series Cuda TriOptic light heads. The visor is constructed of aluminum and finished with a black textured powder paint.

B. UNPACKING.

After unpacking this mounting kit, carefully inspect for damage that may have occurred during transit. If the kit is damaged, file a claim immediately with the carrier, stating the extent of damage. Carefully check all envelopes, shipping labels and tags before removing or destroying them. Ensure that all parts in the following KIT CONTENTS LIST have been included.

D. INSTALLATION.

A WARNING

This product is intended for supplemental warning and for use in conjunction with an approved primary warning light system.

When installing equipment inside air bag equipped vehicles, the installer MUST ensure that the equipment is installed ONLY in areas recommended by the vehicle manufacturer. Failure to observe this warning will reduce the effectiveness of the air bag, damage the air bag, or potentially damage or dislodge the equipment, causing serious injury or death to you or others.

- 1. See figure 1. Remove the end cap and gasket from one side of the unit by removing the two flat head screws. Retain the two screws for replacement of these parts.
- 2. Slide the two hex machine screws supplied with this kit into the upper most screw channel on the light head. Refer



to any additional instructions supplied with the light head or mounting accessories for additional bracket attachment details.

- 3. Replace the end cap and gasket using the flat head screws removed in step 1.
- 4. See figure 2. Attach the sun visor to the light head suing the KEPS nuts supplied with this kit.
- 5. Refer to instructions packaged with the control unit for proper electrical connections.


